CLAIRE NILSEN BLUMENSON

Claire has focused her career on the intersection of juvenile justice and education. After graduating from University of Virginia Law in 2011, Claire joined the Public Defender Service for the District of Columbia as an Equal Justice Works Fellow. Through this two-year fellowship, sponsored by Greenberg Traurig, Claire provided post-disposition special education representation to youth ages 18-22 who had been placed in DC's secure juvenile facility. To continue this work, she co-founded and launched School Justice Project (SJP) in August 2013. SJP is a special education legal services nonprofit for older court-involved youth in DC.

Prior to working at PDS, Claire received her Bachelor of Arts from Wesleyan University, majoring in government, sociology, and psychology. Claire earned her Masters in Teaching while serving as a corps member of Teach for America in Brooklyn, New York. Claire taught third and fourth grade at Excellence Boys Charter School, part of the Uncommon Schools, Inc.

Claire is an attorney admitted to practice in the District of Columbia and the Commonwealth of Massachusetts.

KAREN BOWER

Karen Bower has been representing parents as member of the CCAN panel since 2011. She also has a private practice in which she represents students with mental illness in higher education, focusing on students who have been charged with disciplinary action, have been placed on involuntary leave of absence, or have been denied reasonable accommodations. From 2004 to 2011 she worked as a senior staff attorney at the Bazelon Center for Mental Health Law Center where she conducted impact litigation and federal class action litigation on a broad array of issues that affect people with mental illness, including discrimination, de-criminalization and community integration. She previously was a clinical professor in the DC Law Students in Court Program where she taught trial practice and procedure and supervised third year law students in the representation of indigent clients in landlord-tenant and consumer cases in the D.C. Superior Court. She was also a staff attorney at the ACLU National Prison Project where she undertook federal class action litigation challenging unconstitutional practices and conditions of confinement. She just became a member of the mental health panel.

SARAH COMEAU

Sarah graduated from American University's Washington College of Law (WCL) cum laude in 2011. Prior to co-founding the School Justice Project, Sarah was an associate at a District of Columbia law firm that specialized in special education advocacy, representing students and families of students involved in both the juvenile justice and abuse and neglect systems. After graduating from law school, Sarah was awarded a JD Distinguished Fellowship at the Juvenile Services Program at the Public Defender Service for the District of Columbia.

Sarah focused her law school career on indigent representation and the protection of civil and human rights. She was a student defense practitioner at WCL's Criminal Justice Clinic, a law clerk at a Maryland law firm that specialized in post-conviction representation, and an advocate for international human rights. Sarah received her bachelor's degree in Integrated Marketing Communications from Ithaca College's Roy H. Park School of Communications.

Tim joined the National Juvenile Defender Center in 2012. In his capacity as the Director of Training and Technical Assistance, Tim regularly works with front-line defenders, policymakers, and justice system stakeholders across the country to help support and develop specialized juvenile defense practice that is developmentally-appropriate, draws from national best practices, and provides youth with the highest-quality representation available. Prior to joining NJDC, Tim was the Supervising Attorney at D.C. Law Students in Court and an E. Barrett Prettyman Post-Graduate Fellow at Georgetown University Law Center. In both of those positions, he defended juveniles and adults accused of crimes in Washington, D.C. while also supervising the practice of third-year clinical students and teaching law school seminars on juvenile defense and trial skills. Prior to earning his law degree, Tim worked with various humanitarian relief and refugee organizations in Africa and had a career in journalism. Tim holds an LL.M. in Advocacy from Georgetown University Law Center, a J.D. from American University Washington College of Law, and a B.S. in Broadcast Journalism from Syracuse University.

HON. CAROL ANN DALTON

Judge Carol Ann Dalton was appointed to the Superior Court of the District of Columbia in 2008.

Judge Dalton is the Presiding Judge of the Family Court. From January 2014 through December 2016, Judge Dalton was the Deputy Presiding Judge of the Family Court. Since her appointment as an Associate Judge, she has served on the Mental Health, Private Adoptions, Juvenile Behavioral Diversion, Domestic Relations and Child Abuse and Neglect Calendars.

From 2002 until her appointment as Associate Judge in 2008, Judge Dalton was a Magistrate Judge in the Family Court presiding mainly over child abuse and neglect matters. From 2000 until her appointment as a Magistrate Judge in 2002, Judge Dalton was Director of the D.C. Superior Court's Counsel for Child Abuse and Neglect Office.

Over the years Judge Dalton participated as a member of a number of committees tasked with improving court procedures and practices in the area of family law. These committees included: Family Court Training; Family Court Implementation; Family Court Advisory Rules and Practice Standards; Superior Court Domestic Relations; Neglect and Abuse Subcommittee; Initial Arraignments Working Group; Mental Health Stakeholders and Mental Health and Habilitation Subcommittee.

Prior to Judge Dalton's tenure with the Superior Court, she maintained a private legal practice that included child abuse and neglect, probate, and corporate law.

Judge Dalton received a B.A. from the City College of the City of New York, a J.D. from New York Law School, and a LLM from the George Washington University's National Law Center.

Judge Dalton has been a resident of the District of Columbia for 30 years. She is a former D.C. Advisory Neighborhood Commissioner. Judge Dalton served as Chair of several committees of the D.C. Women's Bar Association and volunteered and Whitman-Walker and other local not for profit organizations.

Before entering private practice, Kim was a Staff Attorney for the Legal Aid Bureau in Riverdale, Maryland, where she represented indigent clients in a wide range of civil matters and a Skadden Fellow at the National Women's Law Center, working on issues related to Family Economic Security. SONALI KHADILKAR

The owner of Khadilkar Law, Sonali Khadilkar, has committed her career to family law for many years. In this role, Clare advocates for committed and detained youth at the Youth Services Center (YSC) and at New Beginnings Youth Development Center. Clare represents youth in commitment revocation hearings, litigates habeas petitions and Article VI oppositions in Superior Court, and addresses conditions of confinement issues inside of the youth detention facilities. Prior to her position at PDS, Clare represented juvenile clients in Superior Court through her fellowship with D.C. Lawyers for Youth. Clare received her B.A. in political science from UCLA in 2009 and her law degree from Georgetown University Law Center in May 2014. At Georgetown Law, Clare was a Public Interest Law Scholar and a Public Interest Fellow. WHITNEY LOUCHHEIM

Whitney Louchheim is an impassioned advocate for the rights and well-being of youth in the deep end of the juvenile justice system. As a defense attorney, she works every day with youth who are struggling to navigate the complexities of the justice system or who yearn to come home from incarceration to be with their families. Her passion for this began while she was a law student at American University. As a law clerk, Whitney was horrified to see a small child, shackled and scared, standing alone in juvenile court. And then to see it again, and again. She began to understand the enduring racial injustice and the generations of violence and poverty that so many of DC's children must overcome. She became determined to forge a career that would right these wrongs. Whitney soon joined her close friend, Penelope Spain, in mentoring incarcerated youth at Oak Hill, a facility rife with violence and appalling conditions. The value of a meaningful human connection – as both a mentor and an advocate – became paramount. She realized the critical need for youth to have an attorney by their side during these traumatic years – to combat inhumane conditions of confinement, to ensure fairness in a system with few written rules, and to defend the youths' ability to remain with their families. Upon graduation, Whitney and Penelope founded Open City Advocates to do just that. As Chief Operating Officer of Open City Advocates and as an Adjunct Professor at Georgetown Law, Whitney provides her clients with long-term, holistic representation. Her defense team includes law students who develop unique relationships with each client. Finally, Whitney is grateful to have learned how to take care of her own well-being as well. She loves traveling to new places, running (especially in the rain), meandering through DC's parks, and going on adventures with her husband and two young boys.

HOWARD MARGULIES

Howard Margulies is an attorney in private practice, representing adults and children in D.C. Family Court. He is a member of the D.C. Family Court CCAN, Juvenile, PINS and Special Education panels. Mr. Margulies is barred to practice law in the District of Columbia and the State of Maryland. Previously, he worked as a trial attorney for the Maryland Public Defender, representing indigent clients charged with felonies in Baltimore City as well as investigating and litigating post-conviction cases on a statewide basis.

Penelope grew up in Napa, California, where she was first exposed to injustice and inequality. Deeply troubled by her community's animosity towards the Latino immigrants on which the area's wine industry depends, Penelope embarked on a life journey to seek out and remedy injustice. She first obtained a bachelor's degree with honors in Latin American Studies from the University of Chicago. She then headed to the jungles of Venezuela to improve her Spanish and teach children who lived a two-hour walk from the nearest school how to read. While in Venezuela, she connected with Jimmy Carter's nonprofit organization and subsequently served as an international observer of elections in Venezuela and Sierra Leone. She then headed to Washington, DC, to go to law school at American University's Washington College of Law. She once again looked for where her energy could make the most difference. During an internship with the Public Defender Service for DC, she visited the Oak Hill Youth Center, DC's notorious juvenile detention facility, which has since been shuttered. That day, her heart broke and she found her life's passion – to combat the racial injustice and harmful effects of locking up children. Prior to graduating law school in 2005, she joined forces with a fellow student and dear friend, Whitney Louchheim, to establish Open City Advocates. As CEO of Open City Advocates and as a court-appointed public defender, she fights every day for youth to be released from secure facilities and to empower them in their own journeys. She is also an Adjunct Professor at Georgetown University Law Center and serves in leadership positions of various local and national juvenile justice advisory groups, such as the DC Juvenile Justice Advisory Group where she chairs the Youth Committee, and the Department of Justice's Federal Advisory Committee on Juvenile Justice where she chairs the Transitioning Youth Subcommittee. When she is not busy advocating for the rights of other children, she feverishly tries to keep up with her own two children, ages 3 and 5. To maintain her own wellbeing, Penelope relishes the time she spends with her husband and friends. She is also an avid yogi and meditator who often jumps off the mat or cushion to go for hikes in DC's fabulous parks and woodlands.

ERIKA L. STILLABOWER

Erika L. Stillabower joined the legal ethics program at the District of Columbia Bar in 2013. As Senior Legal Ethics Counsel, she provides guidance to members of the D.C.
